It will be located on the fifth floor of Children's Hospital and includes exam, treatment and conference rooms. There will be a community room that provides an environment of emotional support while care is delivered, and where patients and families may engage in play and educational activities led by specially trained staff. It also includes a pharmacy to provide customized treatment options designed to meet the specific needs of the child.

Northwestern Mutual's Childhood Cancer Program is committed to accelerating the search for cures for childhood cancers and providing support for families battling the disease. The program launched in July 2012 and has touched more than 3,000 families and funded more than 41,000 hours of research.
