"These grants will help provide people-in-need with the foundation for a better life. Our goal is to help strengthen the community by enabling nonprofits to provide immediate assistance where it matters most."

Spotlight on Hope House of Milwaukee

One recipient of a Northwestern Mutual Foundation basic needs grant is the long-term transitional housing nonprofit, **Hope House of Milwaukee**. The organization will allocate the grant funds to support programs such as its **Chrysalis Project**, an initiative designed to meet the housing and developmental needs of chronically homeless families, with a focus on children. Hope House of Milwaukee adopted this program in 1996 to find permanent solutions to chronic homelessness. The program provides stable, long-term housing to women and families as a starting point in tackling the barriers preventing them from reaching residential independence.

"Homelessness is on the rise in Southeastern Wisconsin, especially among single mothers and families who arrive at our doors without a safe place for their children to sleep at night," said Ken Schmidt, executive director, Hope House of Milwaukee. "The Northwestern Mutual Foundation grant will allow Hope House to expand residential and temporary housing. The goal is to not have to turn anybody away in need, and, ultimately, create a ripple effect of positive change in the community."

Funds will also help the nonprofit to continue operating its 34-bed emergency shelter. Last year, Hope House of Milwaukee served more than 13,000 men, women, and children in need of homeless services.
